## Product Description

BeyondTrust Privileged Remote Access Administrative Interface is a web application for administrators to configure and manage the Privileged Remote Access solution.

## Notes

This Voluntary Product Accessibility Template (VPAT) provides guidance on the accessibility characteristics of the **BeyondTrust Privileged Remote Access Administrative Interface** as of **October 29, 2025** and is only valid for the version and date it was tested.

## Evaluation Methods Used

Assistive technology products used as part of testing included Freedom Scientific JAWS 2025, NVDA 2025.1, Freedom Scientific ZoomText 2025, Microsoft Windows accessibility features, and keyboard-only control. Testing was performed with this assistive technology on Chrome and Firefox on Windows 10 and Windows 11.
